OPERATIONS

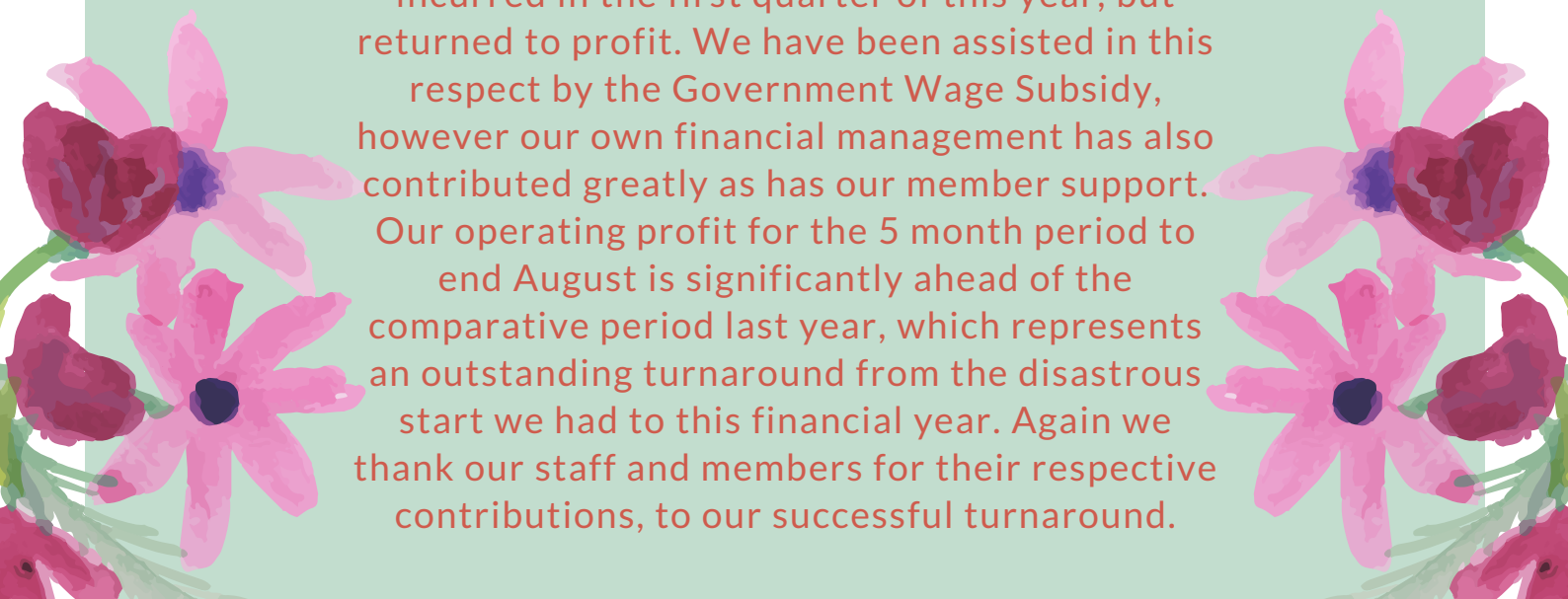

FINANCIAL

Despite the Covid restrictions we are very pleased and proud to report, we have not only overcome the considerable operating loss incurred in the first quarter of this year, but returned to profit. We have been assisted in this respect by the Government Wage Subsidy, however our own financial management has also contributed greatly as has our member support. Our operating profit for the 5 month period to end August is significantly ahead of the comparative period last year, which represents an outstanding turnaround from the disastrous start we had to this financial year. Again we thank our staff and members for their respective contributions, to our successful turnaround.



COMMITTEE APPOINTMENTS

In our report last month, we announced the Committee and Sub-Committee appointments for the current year, as decided at our August meeting. I apologise to all concerned for overlooking the inclusion of our

Planning Sub-Committee which is:-

Craig Macmillan (Chairman), Darryl Le Claire and Andre.

This Group will probably have our biggest workload this year with the projects we are currently working on.

At our September meeting, we confirmed the appointment of Karla Lee, to our Committee. As reported to our AGM, we had accepted a nomination to our Committee of Karla, without her being a member for a minimum of one year, as at the time of acceptance we did not know when we would be holding our AGM. She is now fully eligible under our Constitution and therefore her appointment has been confirmed. As mentioned at our AGM, Karla is the CEO of the Hawkes Bay Chamber of Commerce, so will bring some additional business skills to our Committee. We welcome her to our team.

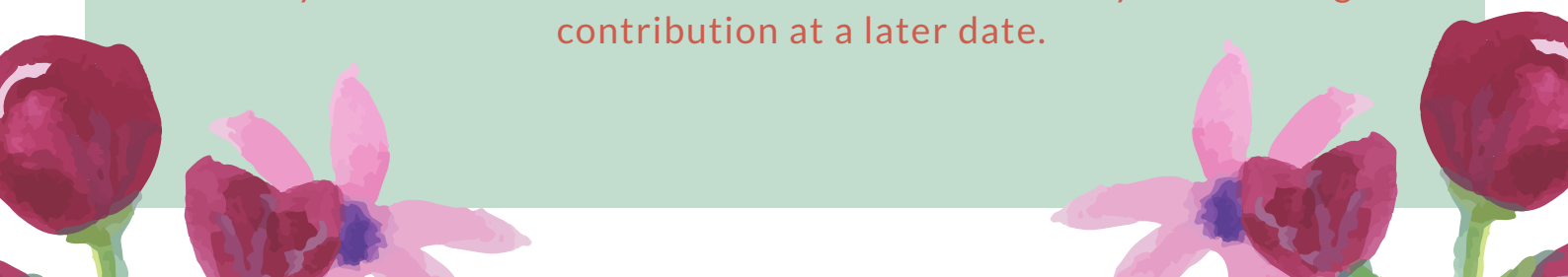
COMMITTEE RETIREMENT

PARTNER MEMBER CATEGORY

At our AGM, we formally introduced a new Partner Member classification to our Membership Categories. This was introduced as an initiative to attract new members, particularly younger couples at a discounted rate to joining as individual members. The qualifying criteria we set, included in the meeting papers and read out to the meeting is as under:-

Rule 6.9 > Partner members shall have rights and privileges as defined in 6.10, except that only the Principal Partner Member shall have voting rights, eligibility to participate in member draws or eligibility to join an Adjunct.

Partner members will therefore have the one membership number for both Partners. Any couples who both want to be Members of any Adjunct, will therefore be required to join as individual members. Joining as Partner members will mean only the nominated Principal member will be eligible to join an Adjunct.

We trust this clarifies the position in this respect.

SUBSCRIPTIONS

A further reminder, Club Subscriptions for ALL MEMBERS, were due and payable by the end of last month, 30 SEPTEMBER. Members who do not pay before 31 October 2020, the end of this month, will not be eligible from that date to accumulate Members Points nor will they be eligible to participate in Members Draws. 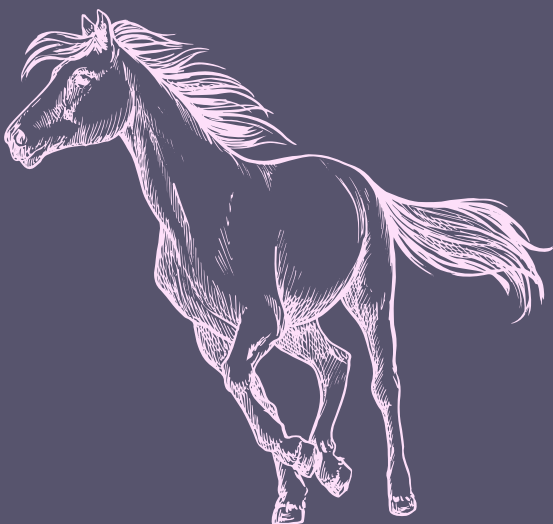
Racing Club

The Trust Fund

We now have a fully established and operational Trust Fund and a Support Advisor team lead by Mike Perreau. Although the start-up has been 'sponsored' by the Greendale Services Assn team, it is in fact a completely stand-alone and independent body from the Services Association. It is our 'gift' to the Club.

The Legal Entity

The Trust Fund is separately Incorporated (No 50027360) by the Companies Office, and is recognised as a totally independent Charitable Trust with Donee Status by the Charities Services section of the Department of Internal Affairs (DIA), and also by the Inland Revenue Department.

The Trustees

The Founding Trustees are Peter Grant (GSA member), Tony Wall (Taradale Club Past President), Kirsten Wise (Mayor of Napier), Alva McAdam (Community Rep and retired nurse), and Frank Keenan (Chair of the GSA). All are very experienced Trustees and provide real knowledge, empathy and financial management skills.

Who Can Benefit From the Trust?

The Trust has been established to serve, support and assist the beneficiaries of the Trust. Importantly this includes ALL members of the Taradale Club. The beneficiaries are highlighted in the Trust Deed.

Trust Focus

The Trust is focused on providing support and welfare to beneficiaries in need. Any funds will be allocated either direct from the Trust to the bank account of a beneficiary, or administered through our Welfare Support team who are accountable to the Trustees. Any equipment like wheelchairs etc will be managed through the welfare team.
